City Manager Loventhal presented a report and answered questions from the Council.

At 7:05 p.m., Mayor Craig invited public comment. There was no one wishing to speak.

Council Member Anstandig moved to approve the resolution amending salary ranges for employees and establishing the position of Management Analyst/Planner. The motion was seconded by Council Member Allan and the motion passed (3-0) with the following vote.

Brief discussion commenced regarding the upcoming open position of Building Official. City Manager Loventhal stated that the City would be considering all viable options with regard to obtaining Building Official services.

6. Consider Resolution Placing Measure Proposing an Increase of City Council Term Limits from 2 consecutive terms to 3 consecutive terms on the November 5, 2014 Ballot

City Manager Loventhal presented a report and answered questions from the Council.

Discussion commenced.

At 7:15 p.m. Mayor Craig opened the floor for public comment. There was no one wishing to speak.

Council Member Allan moved that the Council adopt the Resolution placing a measure proposing an increase of city council term limits from two consecutive four year terms to three consecutive four year terms on the November 5, 2014 ballot. The motion was seconded by Council Member Anstandig.

Council Member Anstandig expressed concern with the language in the proposed ordinance defining the two year hiatus and how it is confusing and may actually prohibit one from being eligible to run in the Council election two years following the last term of service.

The City Attorney suggested the following wording to help clarify the issue raised by Council Member Anstandig - Shall an ordinance be adopted that would change the number of consecutive terms a Council Member rnay serve from two to three with a right to serve again after at least two years have lapse since last holding office.

Council Member Allan moved to arnend the motion as suggested by the City Attorney (above). Council Member Anstandig, seconder of the motion, accepted the amended motion.

Council Member Allan stated that he has gone back and forth with regard to his position on the matter. He reported that he had polled constituents regarding the matter and found that only a few voiced support for extension of the term limits. He expressed concern with the cost of placing the issue on the ballot and the change having little effect. He stated that he hesitates to place the matter on the ballot at such a cost and without strong community support.

Council Member Anstandig stated that he was not in favor of the proposed resolution. He stated that the cost seems to be excessive and extension of term limit is not necessary, since there is already a provision that allows for additional terms. He stated that in a way term limits help to ensure diversity among the Council. He stated that in a community the size of Monte Sereno, civic participation needs to be encouraged and opportunity provided and sometimes re-running of incumbents deter new candidates. He recalled the last time the issue was considered and the opposition voiced at that time.

Mayor Craig agreed that the cost is expensive. However he stated he found some interest and support among the residents of Monte Sereno when he posed the question on a social media site.

Mayor Craig called for the question. The motion (above) failed with the following 1-2 vote:

Nikolas Mekechuck, past youth commissioner, introduced himself and stated that he had enjoyed serving on the Youth Commission and would like to be re-appointed, but that he has temporarily moved out of the City.

Vishall Narayan, Youth Commission applicant, introduced himself and discussed his reasons for wanting to serve on the Youth Commission.

The Council commended the youth for their interest and for introducing themselves to the Council.

Discussion commenced. The Council explained that although Nikolaus Mekechuck had served previously on the Youth Commission, and was and would be an asset to the Youth Commission, and that they would like to re-appoint him to the Youth Commission, the rules governing eligibility of applicants prohibit his appointment at this time. The Council encouraged Nikolaus to continue to participate with the Youth Commission and at the time he has resumed his residency in the City, to contact staff so that his appointment to the Youth Commission can be promptly placed on the City Council agenda.

Council Member Allan moved that the Council appoint all ten applicants. The motion was seconded by Council Member Anstandig and the motion passed with the following 3-0 roll call vote:



2014/2015 Youth Commission Appointment

### **RECCOMENDATION:**

Staff recommends the City Council consider the application for Youth Commissioner and appoint the applicant to the Youth Commission.

### BACKGROUND/DISCUSSION:

The Youth Commission ordinance allows for up to twelve (12) Youth Commissioners. At the July 15, 2014 City Council meeting, the Council appointed 10 applicants. The City had received an application from Ashlee Kupor seeking re-appointment prior to the filing deadline. Ms. Kupor's application had inadvertently been left out of the packet presented to the Council at the last City Council meeting.

By making the requested appointment the Monte Sereno Youth Commission will have 11 filled seats leaving 1 yet to be filled.

### RECOMMENDATION:

City staff recommends that the City Council consider the information and provide direction to staff.

### **BACKGROUND/DISCUSSION:**

The City Council recently made appointments to the Monte Sereno Youth Commission. The Council is also considering an additional appointment earlier on City Council agenda at this meeting. If the City Council makes the additional appointment the City will have filled 11 out of 12 seats on the Commission. However, during the recent appointment process some City Council members questioned whether the residency requirement for youth commissioners should be revised.

Monte Sereno Municipal Code Section 12.03.020 sets the minimum qualifications for the Youth Commission. An excerpt of the code follows:

- "A. The Commission shall consist of a minimum of five (5) and a maximum of twelve (12) members, each of whom shall serve for a term of one year. Commissioners shall be appointed during the month of August of each year and serve until the following August.

  P. All members of the Commission shall be residents of the City of Monte Serven.
- B. All members of the Commission shall be residents of the City of Monte Sereno.
- C. All members shall be, at the time of appointment, enrolled in grades eight (8) through twelve (12), or entering grades eight (8) through twelve (12) in the next school year. "

### RECOMMENDATION:

Introduce and hold the first reading of an ordinance, as read by title only, repealing Monte Sereno Municipal Code Chapter 7.02 relating to swimming pool service regulations, and to waive further reading of the ordinance.

### BACKGROUND/DISCUSSION:

Monte Sereno Municipal Code Chapter 7.02 regulates swimming pool services. The code requires that swimming pool professionals be certified or registered with Santa Clara County. The regulation was adopted many years ago and is no longer applicable. Therefore, staff recommends that the City Council consider repealing the regulation by ordinance.

# AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MONTE SERENO REPEALING MONTE SERENO MUNICIPAL CODE CHAPTER 7.02 REGULATING SWIMMING POOL SERVICES

Be it ordained by the City Council of the City of Monte Sereno as follows:

**SECTION 1.** Title 7 of the Monte Sereno Municipal Code is hereby amended by repealing Chapter 7.02.

### **SECTION 2. EFFECTIVE DATE.**

This Ordinance shall take effect thirty (30) days after the date of its passage, and shall be posted within the City of Monte Sereno in three (3) public places.

### **SECTION 3. SEVERABILITY.**

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction such portion shall be deemed a separate, distinct and independent provision of such Ordinance and shall not affect the validity of the remaining portions thereof.

Discuss Monte Sereno Traffic Circulation

### **RECOMMENDATION:**

City staff recommends that the City Council consider the information and provide direction to staff.

### BACKGROUND/DISCUSSION:

Over the years the City receives periodic complaints from residents about vehicle traffic in their neighborhood. Complaints range from vehicles not stopping at stop signs, vehicles driving too fast and vehicle volume on streets. In these cases the City typically will request additional traffic enforcement. However, residents often have the expectation that the City will install speed humps, close the street off, reduce speed limits, or install new stop signs. Although every case is different the City has in the past explored various traffic calming alternatives depending on the circumstances.

If the Council is interested in exploring this issue City staff will develop a summary of traffic alternatives that have been used over time. Staff would also analyze the cost and effectiveness of the alternatives. The intent would be to provide the City with a comprehensive list or "tool box" of acceptable traffic calming measures that could be considered on a case by case basis to solve traffic concerns should they arise in the future.

This work would entail consulting with a traffic engineer and the Los Gatos/Monte Sereno Police Department to develop the necessary information.
