

RESOLUTION NO. 3707

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MONTE SERENO RESCINDING THE SUBMISSION TO THE QUALIFIED ELECTORS OF THE CITY OF MONTE SERENO OF A CERTAIN MEASURE RELATING TO RESOLUTION NO. 3621 AMENDING THE MONTE SERENO GENERAL PLAN TO CREATE A PUBLIC/RESIDENTIAL MULTI-FAMILY LAND USE DESIGNATION AND TO AMEND THE LAND USE DESIGNATION FOR THAT CERTAIN PROPERTY LOCATED AT 17765 DAVES AVENUE AS PUBLIC/RESIDENTIAL MULTI-FAMILY AT THE GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 6, 2018, AS CALLED BY RESOLUTION NO. 3654

WHEREAS, a General Municipal Election on Tuesday, November 6, 2018 has been called by Resolution No. 3654 adopted on June 6, 2017, due to the filing of a referendum petition challenging Resolution No. 3621, a resolution amending the Monte Sereno General Plan to create a Public/Residential Multi-Family land use designation and to amend the land use designation for that certain property located at 17765 Daves Avenue as Public/Residential Multi-Family; and

WHEREAS, California Government Code section 9241 requires the City Council to either repeal Resolution No. 3621 in its entirety, or submit Resolution No. 3621 to the voters; and

WHEREAS, on August 14, 2018, the City Council rescinded Resolution No. 3621; and

WHEREAS, the City Council desires to rescind the ballot question relating to the General Plan Amendment.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MONTE SERENO DOES HEREBY RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the City Council, pursuant to its right and authority, does order repealed Resolution No. 3654 to remove the following question from the General Municipal Election:

Shall Resolution No. 3621, entitled "A Resolution of the City Council of the City of Monte Sereno Amending the Monte Sereno General Plan to Create a Public/Residential Multi-Family Land Use Designation and to Amend the Land Use Designation for that Certain Property Located at 17765 Daves Avenue as Public/Residential MultiFamily," be adopted? SECTION 2. That in all particulars not recited in this resolution, the election shall be held and conducted as provided by law for holding municipal elections.
