

RESOLUTION NO. 3677

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MONTE SERENO OF
DECLARING INTENTION TO ORDER THE LEVY AND COLLECTION OF
ASSESSMENTS PURSUANT TO THE LANDSCAPING ACT OF 1972

FISCAL YEAR 2018-2019

ROSE-ANDREWS LIGHTING DISTRICT

RESOLVED, by the City Council of the City of Monte Sereno, County of Santa Clara, State of California as follows:

WHEREAS, pursuant to Resolution No. 3675 Describing Improvements and Directing Preparation of Engineer's Report for Fiscal Year 2018-2019 , for Rose-Andrews Lighting District, adopted on April 3, 2018, by the City Council of said City, pursuant to the Landscaping and Lighting Act of 1972, the Engineer of Work of said report called for under said Act and by said Resolution No. 3675 which said report has been submitted and preliminary approved by this Council in accordance with said Act,

NOW, THEREFORE, IT IS HEREBY FOUND, ORDERED AND DETERMINED as follows:

1. In its opinion the public interest and convenience require and it is the intention of this Council to order the levy and collection of assessments for Fiscal Year 2018-2019 pursuant to the provisions of the Landscaping and Lighting Act of 1972, Part 2,

Division 15 of the Streets and Highways Code of the State of California, for the construction or installation of the improvements, including the maintenance of servicing, or both, thereof, more particularly described in Exhibit "A" hereto attached and by reference incorporated herein.

2. The cost and expenses of said improvements, including the maintenance or servicing, or both, thereof are to be made chargeable upon the assessment district designated as “Rose-Andrews Lighting District”, the exterior boundaries of which district are the composite and consolidated area as more particularly described on a map thereof on file in the Office of the Clerk of said City, to which reference is hereby made for further particulars. Said map indicates by a boundary line the extent of the territory included in the district and of any zone thereof and the general location of said district.

3. Said Engineer’s Report prepared by the Engineer of Work of said City, preliminary approved by this Council, and on file with the Clerk of this City is hereby referred to for a full and detailed description of the improvements, the boundaries of the assessment district and any zones therein, and the proposed assessments upon assessable lots and parcels of land within the district, including the annual installment fixed for fiscal year 2018-2019 pursuant to Resolution No. 657 adopted by this Council on June 2, 1980.

4. Notice is hereby given that Tuesday, the 15th day of May, 2018 at the hour of 7:00 p.m. in the regular meeting place of said Council, in the City Hall located at 18041 Saratoga-Los Gatos Road, Monte Sereno, California 95030, be, and the same hereby are appointed and fixed as the time and place for a hearing by this Council on the question of the levy and collection of the proposed assessment for the construction or installation of said improvements, including the maintenance and servicing, or both thereof, and when and where it will consider all oral statements and all written protests made or filed by any interested person at or before the conclusion of said hearing, against said improvements, the boundaries of the proposed assessment, to the Engineer’s estimate of the cost thereof, and when and where it will consider and finally act upon the Engineer’s Report.

5. The Clerk of said City be, and is hereby directed to give notice of said hearing by causing a copy of this Resolution to be published once in the LOS GATOS WEEKLY TIMES, a newspaper published and circulated in Santa Clara County, there being no newspaper published in said City, and by customarily used by the City for the posting of notices, said posting and publication to be had and completed at least ten (10) days prior to the date of hearing specified herein.

6. The office of Director of Public Works of said City be, and is hereby, designated as the office to answer inquiries regarding and protest proceedings to be had herein, and may be contracted during regular office hours at the City Hall, 18041 Saratoga-Los Gatos Road, Monte Sereno, California 95030 or by calling (408)354-7635.

EXHIBIT "A"

ROSE-ANDREWS LIGHTING DISTRICT

The construction or installation, including the maintenance or servicing, or both, thereof of existing public lighting facilities for the lighting of public places, including standards, luminaries, poles, supports, conduits, pipes, wires, conductors, insulators, contacts, switches, capacitors, appliances, attachments and appurtenances, including the cost of repair, removal or replacement of all or any part thereof and the furnishing of electric current or energy.
